• The potential toxicity of residual base oils is independent of the degree of processing the oil receives.

The reproductive and developmental toxicity of the distillate base oils is inversely related to the degree of processing.

Unrefined & mildly refined distillate base oils contain the highest levels of undesirable components, have the largest variation of hydrocarbon molecules and have shown the highest potential cancer-causing and mutation-causing activities. Highly and severely refined distillate base oils are produced from unrefined and mildly refined oils by removing or transforming undesirable components. In comparison to unrefined and mildly refined base oils, the highly and severely refined distillate base oils have a smaller range of hydrocarbon molecules and have demonstrated very low mammalian toxicity. Testing of residual oils for mutation-causing and cancer-causing potential has shown negative

	results, supporting the belief that these materials lack biologically active components or the components are largely non-bioavailable due to their molecular size. Toxicity testing has consistently shown that lubricating base oils have low acute toxicities. Numerous tests have shown that a lubricating base oil s mutagenic and carcinogenic potential correlates with its 3-7 ring polycyclic aromatic compound (PAC) content, and the level of DMSO extractables (e.g. IP346 assay), both characteristics that are directly related to the degree/conditions of processing. For unrefined and mildly refined distillate base oils: Acute toxicity: Animal testing showed high semilethal doses of >5000 mg/kg body weight and >2 g/kg body weight for exposure by swallowing or skin contact, respectively. The same material was also reported to be moderately irritating to skin, while not being sensitizing. Repeat dose toxicity: Animal testing showed that repeat dose toxicity was mild to moderate to the skin. Reproductive / developmental toxicity: No studies on developmental toxicity or reproduction are available. Animal testing shows that high doses may reduce the body weight of both the mother and the foetus, and increase the rate of soft tissue malformations. Genetic toxicity: These oils have been found to cause mutations. Cancer-causing potential: The general conclusion that can be drawn from animal testing is that these oils may potentially cause skin cancer; however, they have not been found to be associated with an increase in tumours elsewhere in the body.
